PolimiRun Winter 2025 – 10 km non-competitive race

The Polisportiva Politecnico di Milano SSD, affiliated with C.S.A.In. – *Centri Sportivi Aziendali e Industriali*, organizes **the PolimiRun Winter non-competitive race**, a trail run event on mixed route, road and dirt, on a 10 Km route.

The PolimiRun Winter 2025 is a **non-competitive race open to everyone**.

The race is not subject to control by G.G.G. Fidal, but it will be timed by a tracker chip provided with the racing bib.

The 10K race route will be on a single route, with the start from Politecnico di Milano – Lecco Campus and finish line at Politecnico di Milano – Lecco Campus, via Ghislanzoni.

The race will take place on Sunday 9 November 2025, with the start at 09:30 am and it will take place in any weather conditions.

The organizing committee reserves the right to modify the route in accordance with any requests from the competent authorities or for particular weather conditions, after communicating it to C.S.A.In. – *Centri Sportivi Aziendali e Industriali*.

Time Limit: 1 h and 40 minutes

Climb (D+): 425 mt

Maximum slope 44%

PARTICIPATION RULES

You can register for the race from the age of 14 on the date of the event. For young runners, it is necessary authorization from a parent, to be signed during registration.

Children under the age of 13 can PARTICIPATE to the PolimiRun Winter free of charge, but they must come with a parent and they will not have a racing bib.

OPENING OF REGISTRATION

It will be possible to register for the PolimiRun Winter 2025 from September 25th to November 7th, 2025.

The organization reserves the right to open registrations before or after the aforementioned date and / or to close registrations early or accept registrations after the closing date at its sole discretion.

INDIVIDUAL REGISTRATION FEE

REGISTRATION PROCEDURE

Registrations can be made online by following the instructions on the website

<https://www.sport.polimi.it/en/events/polimirun-winter> under the heading **SIGN UP**. Payment can be made by credit card or other online payment methods.

The organizer can collect registrations even physically at special desks set up in the days preceding the race with any promotional rates.

REGISTRATION CONFIRMATION

At the time of registration, each member will receive an email with the bib number and how to collect it. This email will be the only valid document for the withdrawal of the breastplate; it will be showed to the desk.

REIMBURSEMENT OF PARTICIPATION FEE

Registration fees are not refundable under any circumstances.

END OF REGISTRATION

Online registrations will close on **Friday 7 November 2025 at 11:59 pm**. Registrations after these deadlines will not be accepted. The organization reserves the right to close registrations or to accept registrations after the closing date at its sole discretion.

On Sunday 9 November 2025 ENROLLMENTS WILL NOT BE ACCEPTED.

COLLECTION OF RACING BIB/BAG

The racing bib is strictly personal, it cannot be tampered with or reduced and it cannot be given to anyone else, or you will be disqualified. The racing bib and the race pack can be collected after showing the registration receipt (the confirmation email with the bib number assigned) together with a valid identity document, on the following days:

- **Friday 7 November 2025 from 11 AM to 7 PM** - Leonardo Campus, Gardella Terrace, Piazza Leonardo da Vinci, Milan
- **Saturday 8 November 2025 from 10 AM to 4 PM** - Lecco Campus, Via Ghislanzoni 22

For organizational reasons, **NO racing bibs and race packs will be given to the athletes on the morning of 9 November 2025, day of the race.**

N.B.: Only residents from outside the region will be able to collect the racing bib, the chip and the race pack on the morning of 9 November 2025, from 7:30 am to 8:15 am at the Village located in Lecco Campus.

The organization reserves the right to change dates and times for bib collection. Any changes will be communicated by email to each registered participant by Thursday 6 November 2025.

Together with the racing bib, every registered person will have: PolimiRun Winter official T-shirt, pins to apply the bib number to the T-shirt, race pack with the sponsors products, ticket to be attached to the bag during its storage.

When you collect your kit, you will receive the shirt in the size you specified when you registered. Under no circumstances can the shirt you receive be exchanged for another size.

The race kit can be collected only and exclusively in the places, days and times indicated.

BAG CUSTODY SERVICE

When you pick up your race kit, you will receive, among other things, a ticket with your bib number, a pin and the adidas race bag. Use the pin to attach the ticket to the bag and transfer everything you want to find on arrival inside.

The provided bag, duly numbered by the application of the sticker, will be the only bag accepted by the organization for the bag storage service and it can be delivered to the storage areas set up at the PolimiRun Village in Via Ghislanzoni 22, Lecco, on Saturday (from 10:00 am to 4:00 pm) and Sunday (from 7:30 am to 8:30 am). Bags will be got back at the end of the race and until 1:00 pm.

START

PolimiRun Winter 2025 will start on Sunday 9 November at 09:30 am from via Ghislanzoni, Lecco. The starting methods will be communicated via the official website of PolimiRun Winter 2025 and via email to all those registered in the days preceding the race.

Changes in the starting time will be possible in case of television needs, safety on the route or other indications from the Institutions.

TIMEKEEPING DEVICE

The measurement of time will be performed by a system based on an active transponder (chip) applied to the racing bib. It is strictly forbidden to tamper with the chip. The time of athletes that, in any way, will tamper with the chip will not be taken and they will not be shown in the race ranking.

For each participant the official competition time will be recorded. These data can be seen, in alphabetical order, on the web site <https://www.sport.polimi.it/en/events/polimirun-winter>.

TIME LIMIT

The time limit to arrive at km 10.00 is 1h and 40 minutes. After this period of time, the organization will no longer be able to guarantee the right conclusion of the foot race.

HEALTH SERVICE

The Organizing Committee will prepare an appropriate medical assistance service on the route and at the start and finish line.

ATHLETE RESPONSIBILITY

The runner is responsible for the ownership of his/her racing bib, acquiring the right to use all the services mentioned in this regulation and subsequently communicated.

FINISH LINE

After the finish line, the athletes can access the the final refreshment and the PolimiRun Winter 2025 Final Village.

NON-PERFORMANCE

If the race is canceled and / or, in any case, not held for reasons not dependent on and / or not attributable to the will of the organizers, including the revocation of the authorization to carry it out by the competent Public Bodies, for any reason, the subscriber cannot claim anything from the Polisportiva Politecnico di Milano SSD or from other co-organizers, not even by way of reimbursement of the expenses incurred as the signing of the registration application is also valid as a waiver of any claim for compensation for damage and / or compensation and / or any reinstatement and / or satisfactory claim of any financial damage suffered and undergoing.

DECLARATION OF RESPONSIBILITY

I declare to accept the regulation published on the web site

I declare that I am 18 years old and that the person(s) registered under my personal responsibility is/are 14 years old on the day of the event scheduled for 9 November 2025.

I am aware that participating in the PolimiRun Winter 2025 and/or in general to sporting events is potentially a risky activity. I also declare to register voluntarily and I take complete responsibility for all the risks coming from my participation in the event: falls, contacts with vehicles, with other participants, public or other, weather conditions, including extreme heat or cold and/or wet, traffic and road conditions, every kind of risk that I well know and I properly take into account. Being aware of the above, considering the acceptance of my registration, I, on my behalf and in the interest of no one else, relieve and free the Organizing Committee of PolimiRun Winter 2025, the Polisportiva Politecnico di Milano SSD, A&C Consulting Sas and Politecnico di Milano and the promoter bodies, as well as the Municipal Administration of Lecco, the Regional Administration of Lombardia, all sponsors of the event, their representatives, successors, officials, directors, members, agents and employees of the aforementioned companies, of all present and future claims or responsibilities of any kind, known or unknown, coming from my participation in the event. Once the registration to the PolimiRun Winter 2025 is accepted, the participation fee is non-refundable, even in case of cancellation.

For the purposes of applying the relevant European and national legislation (Reg. EU 679/2016, henceforth Regulation), we inform you that your personal data shall be used for the following purposes:

During the PolimiRun Winter 2025, images will be acquired in the form of photographs or videos that will be used for the purpose of broadcasting the various moments of the event - on promotional material for the event, on social media and in the press - in exercise of the right to inform.

The images, both photographs and videos, shall be stored in the computer archives of the Politecnico di Milano and/or of the partners participating in the event.

By accepting the event Regulations, you grant a non-exclusive license to use the Materials, with no limit of duration and for the whole world, transferable to third parties. This includes the rights referred to in Articles 12 to 19 of the Italian Law No 633 of 22 April 1941, including but not limited to: right of publication; right of reproduction in any manner or form; right of transcription, editing, adaptation, processing and reduction; right of disclosure and distribution to the public, including the rights of projection, transmission and dissemination even in summarised and/or abridged version, by any technical means; right to keep a copy of the Materials, also in electronic form and on any known technological support or future invention for the purposes and within the limits defined above.

Pursuant to the aforementioned Article 97 and pursuant to Art. 10 of the Italian Civil Code, any use of the images that could prejudice the honour, reputation or dignity of the person portrayed, filmed or recorded.

During the PolimiRun Winter 2025, the service named ENDUpix will be made available in order to allow the participant to identify and purchase photos of the sports event portraying them. In relation to the aforementioned service, Engagigo S.r.l., the company providing the ENDUpix service, is to be considered the data controller of the particular personal data necessary for the provision of the service. Nature of the processing

The provision of the data requested for Purpose 1 in the table is mandatory. Refusal to provide the data shall mean you cannot take part in the sports event.

The provision of the data requested for Purpose 2 in the table is mandatory. Refusal to provide the data shall mean you shall be unable to access the newsletter service envisaged.

Processing methods

The data are processed for the formalization and consequent organizational, administrative, legal and fiscal management of the contractual relationship that results from acceptance of your registration by the Politecnico di Milano.

In addition, the data shall be:

- processed for the purpose of sending you any information you may need to participate in the sports event or other activities that take place as part of the event;
- processed for the purpose of sending newsletters promoting sports events at the Politecnico di Milano, as established for Purpose 2 shown in the table;
- processed electronically and on paper by internal staff, authorized collaborators and external data processors duly appointed by the Politecnico di Milano;
- stored in computerised form or on paper and protected from unlawful or unauthorized access, theft, loss and destruction with adequate security measures;
- shared with partners participating in the event, subject to prior consent, as well as for insurance purposes;
- health data are also processed in the form of the medical certificate of suitability for non-competitive and/or competitive sporting practice and/or FIDAL card/run card/FCI card/EPS card/UCI card required, for the purpose of the correct carrying out of the event for competitive athletes; the data will be used only and exclusively for the purpose described.

Categories of recipients

In relation to the purposes indicated, the data may be communicated to public and/or private subjects, or they may be communicated to companies and/or persons who provide services, including external ones, also on behalf of the Data Controller.

Furthermore, your personal data may also be communicated to other public administrations, including anonymously if they have to process the same for any proceedings within their institutional competence as well as to all those public entities to which, in the presence of the relevant conditions, the

communication it is compulsorily provided for by provisions of the European legal system, laws or regulations, as well as insurance bodies for any accident practices.

They are responsible pursuant to art. 28 of the EU Regulation:

- Avaibook Sports, for the collection of registrations for the non-competitive sporting event;
- A&C Consulting company, for the purpose of technical management of the sporting event.

Rights of data subjects

As a data subject, you can ask the Data Controller for the following at any time:

- confirmation of any personal data held concerning you;
- access to your personal data and related information; the correction of inaccurate data or the completion of incomplete data; the cancellation of personal data concerning you (where any of the conditions indicated in Art. 17, paragraph 1 of the Regulation applies and in compliance with the exceptions provided for in paragraph 3 of the same article); the restriction of the processing of your personal data (where one of the conditions indicated in Art. 18, paragraph 1 of the Regulation applies), the transformation into anonymous form or the blocking of data processed in violation of the law, including those that do not need to be kept for the purposes for which the data were collected or subsequently processed;

As a data subject, you also have the right to object in whole or in part:

- for legitimate reasons, to the processing of personal data concerning you, even if pertinent to the purpose of the collection;
- to the processing of personal data concerning you for the purpose of sending advertisements on courses and cultural events at the Politecnico di Milano.

These rights can be exercised by contacting privacy@polimi.it.

If you believe that your rights have been violated by the data controller and/or a third party, you have the right to lodge a complaint with the Personal Data Protection Authority and/or other competent supervisory authority pursuant to the Regulation.
